HHS recently announced that additional funding to the Provider Relief Fund(www.hhs.gov) of \$30 billion allocated to clinicians and facilities based on their proportion of Medicare Part A and B fee-for-service spending in 2019.

The agency is now adding \$20 billion for what it describes as a \$50 billion "general allo cation." Physicians may seek this funding and unlike the first round of payments from the \$30 billion fund, these payments will not come automatically and an application is required. The newly allocated relief funding could go quickly given that providers with large patient revenue, including hospitals, are eligible to apply.

HHS is dispersing the additional \$20 billion to providers based on a percentage of each provider's 2018 net patient revenue from all payors, not just Medicare fee-for-service payments.

- HHS will begin distribution of the remaining \$20 billion of the general distribution to providers to augment their allocation so that the whole \$50 billion general distribution is allocated proportional to providers' share of 2018 net patient revenue.
- Payment to providers from this \$20 billion are calculated so that a provider's allocation from the entire \$50 billion general distribution will be in proportion to such provider's 2018 net patient revenue. Total revenues of Medicare facilities and providers in 2018 is estimated to be \$2.5 trillion. Providers can estimate their expected general revenue distribution through the following formula:
- (Individual Provider 2018 Revenue/\$2.5 Trillion) X \$50 Billion = Expected General Distribution

## Overview of what you will need to have on hand to apply:

- Taxpayer Identification Number (TIN) that has received prior Provider Relief Fund payments
- TINs of subsidiary organizations that have received prior Provider Relief Funds but do not file separate tax forms (i.e., subsidiary organizations that are accounted for in the parent organization's tax filing)
- Medicare ID
- Amount of payments received your share of the initial \$30M. HHS partnered with UnitedHealth Group (UHG) to deliver the stimulus payments, and physicians should contact UHG's Provider Relations at (866) 569-3522 about eligibility, whether a payment has been issued, and where it was sent. The automatic payments will come to the organizations via Optum Bank with "HHSPAYMENT" as the payment description.
- Relief Fund payment transaction numbers/check number
- Lost March 2020 revenues
- Estimated lost April 2020 revenue
- A copy of your most recently filed tax forms; see Appendix A: Federal Tax Classification Matrix (you will need to upload the applicable forms)
